 - register in person for the 2023 State of the County, 1/31. 5:15 to 7 pm.
 - [the CalTrain/County mtg ended and attendees joined this mtg: we had a short debrief:]
 - meeting about the office development east of the Diridon Station; was not as informative as the leaders would have liked. Different parts of puzzle (HSR, BART, Google) each going independent of others -- no coordination. Today's mtg basically was about CalTrain (as land-owner) seeking development entitlement.

- recent "Walk and Talk" was postponed due to the flood alerts. She encouraged everyone to install the AlertSCC app for emergencies.
- District 8 and District 10 are without council representation at this time. Applications are being accepted.
- Dev Davis will be on the Rules and Transportation (CalTrain and VTA) committees. She has regular office hours open to the public Wednesday evenings 6-7pm.
- Alex asked about the tree canopy issue that will be discussed tomorrow at the council meeting

The memo provides recommendations regarding the funds left on the table because DOT isn't replacing trees. The Tree Committee has openings for more community members to join. Provide feedback before noon tomorrow.

- Board and Commission Updates
 - Neighborhood Commission Jim Carter
 - the Neighborhoods Commission is understaffed and work is on hold until Council members submit references/appointments. This may take until March.
 - Jim discussed that Nicole Edraos could help with issues related to fireworks
 - Parks & Rec Commission Art Maurice (D6); Larry Ames (D3)
 - There was a vote on a report of the Fiscal Year 2023 budget.
 - Park Fee Task Force Helen Chapman
 - there are 5 initiatives for Park Land: Equity, Quality, Maintenance, Land Acquisition & Funding. There is concern about the implementation of higher fees to fund these initiatives. This may require a vote of the public for a bond/parcel tax.
 - All Districts Leadership Group Larry Ames / Bill Rankin
 - Jim Carter said Olympia Williams is scheduled to make a presentation to the leadership group. There will be an update from CERT about their efforts to expand participation and response to the flood warnings.
 - Mary Anne asked about possible guest speakers, such as the Parks Department. She is willing to negotiate on our behalf for a speaker. Larry requested Mary Anne get Rebecca Ross and Jon Cicirelli to be a guest speaker for February.
 - Steve Kline offered to invite Susan Ellenberg as a speaker for March meeting.
