 - County working on their redistricting; must be finalized by 12/15/21.

- Advocacy and Community Group updates

- Save Our Trails -- Bill Rankin
 - SOT to start advocating for Guad Riv Trail, Virginia → Chynoweth
 - Ribbon-cutting for Coyote Crk Trail 11/7 at Story/Remilard.
- SJ Park Advocates -- Jean Dresden
 - City has set up a Working Group to study the Nexus for Development Fees. (Meetings have not been open to the public....)
 - City Charter cmte is reviewing "budget equity", with discussions on reallocating money across district boundaries.
 - Guadalupe Gardens: Homeless encampments; FAA says City must make them leave. City: 3-step process: (1) move them from strip on western third of parcel; (2) move from middle; (3) kick them all out. Issues: will cause crowding.
 Q: how to keep them out? Fencing? K-bar (for cars)?
 "Activate" the park? Limit on number of visitors. Can't plant crops: food brings rats, which bring predator birds, which impact low-flying planes.
 Jean suggests plant milkweed, make a butterfly garden!
- Discussions:
 - the redrawing of Council District boundary lines -- Jean Dresden
 - detailed discussion of various plans, "Unity" and "Community", esp on boundaries of D6, impacts to downtown, and Diridon/Downtown West.
 - implications for the future of D6NLG TBD
 - impacts of SB 9 & 10, Opportunity Housing, etc. -- Jean Dresden
 - Complicated; takes effect 1/1/22; City action can affect impact, but they must act before Jan 1st. Lot setbacks reduced from 20' to 4'; impact on SJ ADU law?
 - update process for the City's General Plan -- Larry Ames
 - Council to vote on Coyote Valley 11/6/21.
