 - City is a finalist for a \$1M grant to, basically, beta-test a citizen involvement program
 - need 200 volunteers for application by 10/22/21; have ~120 already
 - SJ has set a goal to be carbon-neutral by 2030
- Elected Officials / Staff Updates
 - Supervisor Ellenberg Steve Kline
 - BoS discussion on closing Reid-Hillview airport
 - Co. is setting up an Afghan refugee referral program. Expects ~300 refugees.
 - Co. working on nurse retention program, to counter burnout
 - State's renter-eviction moratorium has ended. County trying to help.
 - Councilmember Davis Maryanne Groen
 - SJ implementing "HomeKey" program to house homeless in converted motels
 - One site in D6: the Arena Hotel
 - CM will press for CAC (Community Advisory Cmte), like that last year for Bascom, to provide help for n'boring residents
 - Hotel volunteered to be sold for housing: AirBnB is too much competition.
 - ABA Alameda Business Assoc. in process of being reorganized;
 San Carlos Business is being revamped w/ assist from Antiques Colony.
 - should D6NLG reach out to business assoc, or are we just n'hd assocs?

 - Neighborhood Commission Jim Carter see Jim's report²
 - Parks & Rec Commission Art Maurice (D6); Larry Ames (D3)
 - no P&R Cmsn meeting this month.
- Advocacy and Community Group updates
 - Save Our Trails -- Bill Rankin
 - SJ Park Advocates -- Jean Dresden
 - PRNS has set up a task force to study Nexus & Park Fees
 - PDO/PIO impact fees from developers a primary park funding source
 - task force mtgs haven't been open to the public....
 - Milligan Parking Lot proposal
 - on 2.6A by SAP Arena, at Obama & St.John: too close to Guad.River
 - See written comments³ by L.Ames
 - Drought: SCVWD Valley Water convening a task force.
 - SJ PRNS removing turf, but what goes in its place? raw dirt?
 - Homeless in the parks
 - problem aggravated by nearby "Safe Parking" lots
 - arsonists targeting encampments
 - Alum Rock Park is very dry
 - conflicts w/ park users
 - VivaCalleSJ
 - Successful Sept 19th event.
 - City planning another for Nov + 2 more next spring
 - There's a privately-funded park downtown on S. 1st St.
 - City says Urban Confluence (aka "Light Tower") needs more public outreach
 - UC supposed to just pay for moderators/consultants, but UC instead is selecting and hiring them. Inappropriate?
 - Valley Water hosting meetings re: planned flood-control measures along Coyote Crk.
 - others? Jean: Land Use Issues
 - Does SB9 contain a "poison pill"?
 - given concerns about speculators and loss of rental properties, there's a req'mnt that only properties occupied by the owner can be developed, and the owner also has to live on the property for 3 yrs after completion: who'd want to do all that and then live in the resulting smaller/cramped quarters?
 - AB602: "snuck by"; city didn't notice; has been signed by Governor
 - pushed by State to change methodology from 'unit' to 'per sq.ft.' City was already in the process, but now has 2024 deadline.

- must have a new 'template' for 'financing feasibility' or else fees will zero out: developers might not have to pay anything for streets, sewers, parks, ...
- Quasi-Public Lands (schools, churches, etc.)
 - will be allowed to build housing on unused land (e.g., parking lots
 - school enrollment down 30% from peak: families w/ kids can't afford to live in Bay Area. Schools want to sell off unused land for development; exempt from some planning rules, planning mid-rise bldgs. in R1 n'hds.
 - School districts need income: doing land-swaps w/ developers.
- Announcements: SHPNA's Stroll the Alameda is Oct. 17th.
- Continued from last month:
 - D6NLG Finances
 - requirements on grant from UNSCC -- Bill Rankin
 - ~\$1,400; has to be spent by year's end
 - we'd need bylaws, a treasurer, a bank account
 - we don't have any expenses: no major projects planned. If we were to, say, host a candidates' forum, the room-rental fees etc. would be next year: we can consider applying for a grant then if needed.
 - Consensus: return the money. Bill will work w/ past-chair James Rincon to account for funds already spent and to return the remainder.

- Additional topics?
 - Q: should the D6NLG meetings be recorded?
 - Easy to do on Zoom; would make a great archive; available to those who missed the mtg; allows others to go back and refresh memory about what was discussed.
 - On the con side: might intimidate participants and stifle discussion; would make mtgs more structured and somber.
 - Consensus: no great impetus, but let's reconsider at beginning of next mtg.
