- Update on Chick-fil-A on Race St at San Carlos, and related discussions on "qualitative vs quantitative req'mnts" in <u>commercial</u> dev'lpmnts (vis-à-vis state laws re: housing) and the future of Urban Village planning in the General Plan – Ed Saum, Alex Shoor, Jean Dresden
  - State law: requires *Objective* guidelines for housing. Makes approval "ministerial review" to speed up approval process.
  - State Law doesn't have similar law for commercial; they still follow prior rules; can evaluate against General Plan, have public review.
  - Chick fil-A proposal doesn't follow Urban Village guidelines; concerns w/ traffic impacts
  - SJ has housing shortage; shame to waste this prime site, just because property owner doesn't want to follow plan. What happens to City's plans for Urban Villages?
  - Do we want to talk w/ Planning ourselves, or do we host a forum so other groups w/ Urban Villages can attend and ask questions? D6NLG or ADLG? (Note: ADLG is not the N'hds Cmns, and is not limited by the constraints that were put on it.)
  - Ask ADLG to host meeting, and use this Chick fil-A proposal as a "case study" of if/how SJ follow their Urban Village plans. Jim and Bill will help me work w/ Greg at ADLG to do so.
  - make sure other groups know about issue: Five Wounds; Union/Curtner; Almaden Valley Community Assoc (AVCA), etc.
  - Alex: suggest other locations for Chick-fil-A? Not opposing company, just low density of this site.
- Continued discussion, and possible approval, of proposed D6NLG bylaws
  - Judie Ciesla, Mary Pizzo, Larry Ames
  - motion to accept by Mary Pizzo, 2nd by Susan Price; adopted by consensus:
    9 yes, 0 no, 4 abstain. (plus 2 who were unable to vote infrequent attendance.)

- update on sale of "Vermont House" to the County for the prison diversion program Ed Saum
  - City voted Dec. 6th to with process; complained about poor public outreach was handled.
  - Will continue watch how will go.
  - County program. Jail diversion: not arrested, trying to keep them from getting in trouble; assist them and move on to more permanent situation.
  - Need to have community coordination; get input on how to improve the program
- Board and Commission Updates
  - N'hd Assoc. Engagement Model Jim Carter waiting to hear back on evaluation of last event.
  - Parks & Rec Cmsn Larry Ames (D3): next mtg Jan 22nd. nothing new.
  - All Dist. Lead'shp Group Larry Ames / Bill Rankin / Jim Carter: SJADLG is drafting new bylaws.
    - LLA to bring up ALDG hosting Urban Village discussion.

  - Save Our Trails -- Bill Rankin. Next mtg: Jan 27th
  - SJ Park Advocates -- Jean Dresden
    - Study Session for Council mid Feb to go over history of past 20 years; 2 recessions; reduction-in-force; no money coming in this year; need to explain to Council how parks are funded. Polling on tax ballot?
    - General Plan update on parks, due Jan 2026
    - Update of GreenPrint, also for Jan 2026
  - others? Art filed form for BeautifySJ grant, for \$1k, will find out sometime...
